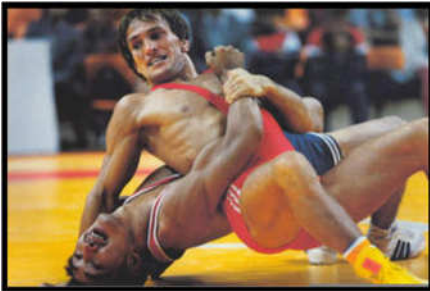

Anatoly Beloglazov



Beloglazov took up wrestling in 1968 and debuted internationally at the 1974 European Junior Championships, where he won a gold medal; next year he won the 1975 World Junior Championships, and in 1976 started competing among seniors, winning the European title that year. Domestically he won four Soviet titles: in 1977, 1979-80 and 1982. He retired from competitions after the 1984 season, missing the 1984 Olympics due to their boycott by the Soviet Union, and then had a long career as a wrestling coach. He headed the Canadian (1990-96), Australian (1996-98), and then Russian and Belarusian national freestyle teams. Since 1998, an annual freestyle wrestling tournament honoring Beloglazov brothers has been held in Kaliningrad.

VOUGAR OROUDJOV



A former member of the Soviet National team, Vougar is a 2x World Champion, Olympic medalist and has claimed titles in many other international competitions. He brought his "Russian Style" wrestling to the U.S.A. and opened VHW in 2006. Vougar coaches at Nassau Community College. Under his guidance, VHW wrestlers achieve their personal best. His wrestlers have gone on to College All-American, Junior College All-American, High School All-American, New York State Champion, All-State, Nassau County Champion, Suffolk County Champion, and All-County honors.

SPORT PARTICIPANT RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT.

Please read and be certain you understand the implications of signing. Express Assumption of Risk Associated with Sport, Venue Use and Related Activities.

I, _____ do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with VHW, Blue & Gold RTC and Barn Brothers Wrestling, transportation of equipment related to the activities, and travelling to and from activity sites in which I am about to engage. Inherent hazards and risks include but are not limited to:

1. Risk of injury from the activity and equipment utilized is significant including the potential for broken bones, severe injuries to the head, neck, and back or other bodily injuries that my result in permanent disability and death. 2. Possible equipment failure and/or malfunction or misuse of my own or others' equipment. 3. I AGREE THAT I WILL WEAR APPROVED PROTECTIVE GEAR AS DECREED BY THE GOVERNING BODY OF THE SPORT I AM PARTICIPATING IN. However, protective gear cannot guarantee the participant's safety. I further agree that no helmet can protect the wearer against all potential head injuries or prevent injury to the wearer's face, neck or spinal cord.

4. Variation and/or steepness of terrain, variation or changes in surfaces including but not limited to snow surfaces, ice, bare spots, rocks, stumps, debris, cliffs, trees, fences, posts, trees, light poles, signs, buildings, roads, walkways, ramps, rails, stairs, pyramids, manual pads, bows, half-pipes, jumps, padded and non-padded barriers, other persons, and other natural and man-made hazards. 5. My own negligence and/or the negligence of others, including but not limited to operator error and guide decision making including misjudging terrain, weather, riding surfaces or other obstacles. 6. Exposure to the elements and temperature extremes may result if frost nip, frost bite, heat exhaustion, heat stroke, sunburn, hypothermia and dehydration. 7. Dangers associated with exposure to natural elements include but are not limited to avalanche, rock fall, inclement weather, thunder and lightning, severe and or varied wind, temperature and other weather conditions. 8. Accidents or illness occurring in remote places where there are no available medical facilities. 9. Fatigue, exhaustion, chill, and/or dizziness, which may diminish my/our reaction time and increase the risk of accident. 10. Impact or collision with other athletes, spectators, facility employees, pedestrians, motor vehicles, and cyclists. 11. I understand the description of these risks is not complete and unknown or unanticipated risks may result in injury, illness, or death. Release of Liability, Waiver of Claims and Indemnity Agreement

To release the releases, their officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releases or otherwise.
