**Midget Division:** (Born in 2000 and 2001) Weights: 50, 54, 58, 62, 66, 70, 75, 80, 85, 93, 105, 134, MAX

**Junior Division:** (Born in 1998 and 1999) Weights: 58, 62, 66, 70, 74, 78, 82, 86, 91, 98, 108, 120, 140, 166, 186, MAX

**Intermediate Division:** (Born in 1996 and 1997) Weights: 75, 80, 85, 90, 95, 100, 105, 110, 115, 120, 128, 136, 150, 175, 220, 240, MAX ( **Varsity and JV experience allowed** )

EVERYONE MUST COMPETE IN THEIR OWN AGE DIVISION EXCEPT those who exceed the MAXIMUM weight.

**LENGTH OF BOUTS:** **Intermediate:** Three 1 1/2 minute periods; All Others: three 1 minute periods; **Overtime-Sudden Death:** One- 1 minute period followed by a 30 second ride out period if necessary. **WRESTLING RULES:** NYS. Modified rules; NYS officials will be used. EVERYONE must have PROOF OF AGE if challenged including the person issuing the challenge. \$25 fee for challenges. All challenges must be made before the completion of the first round.

**UNIFORMS:** One-piece singlets are REQUIRED. No T-shirts .

**AWARDS:** Belts will be given to the Champions in each weight class. Trophies for 2<sup>nd</sup> and 3<sup>rd</sup> place. Metals for 4th place.
