## PARTICIPANTS WAIVER AND RELEASE

In consideration of being allowed to participate in any way in USA Wrestling athletics/sports program and related events and activities the undersigned:

- Agree that prior to participating they will each inspect the facilities and equipment to be used and if they believe anything to be unsafe they will immediately advise their coach or supervisor of such condition(s) and refuse to participate.
- Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury including permanent disability and death and severe social and economic losses which might result only from their own actions, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further that there may be other risks not known to us or not reasonably foreseeable at this time.
- Assume all the forgoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
- Release waive discharge and covenant not to sue USA Wrestling it's affiliated clubs, their respective administrators, directors, agents or coaches and other employees of the organization, other participant's, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as the "releases" from any and all liability to the undersigned, his or her heirs and next of kin, for any and all claims, demands, losses of damages on account of injury including death or damage of property caused or alleged to be caused in whole or part by the negligence of the release or otherwise.
